If you have any events listed on Virginia.org that are canceled or postponed, VTC is asking that you cancel the event on the website. This will help visitors to their site know what events are still taking place throughout the Commonwealth but also help VTC track economic impact from COVID-19.

March is normally the time of year that our business community is gearing up for the tourism season. We are happy to see that several businesses reopened this week but understand that this is a very fluid situation. We want you to know that the chamber is here to support you in any way we can. We will be concentrating on a shop local campaign to encourage locals to continue to support our business community.

If you are hosting any events, we encourage you to:

- Promote sanitation for workers, vendors, exhibitors and participants prior to event
- Review event procedures and modify if necessary to promote social distancing
- Brief participants before events regarding safe practices
- Consider secondary and tertiary planning for events scheduled now up to 6 weeks

As a precaution, our March 18 Members Networking Luncheon at Don's Seafood has been canceled and the March 19 Multi-Chamber Business After Hours at Classic Collections at the Vault have been postponed.
