BREASTFEEDING IN WIC

Arkansas WIC breastfeeding initiation rates increased by 24 percent between 2010 and 2022.

Among WIC infants who initiated breastfeeding in Arkansas in 2022, 13 percent continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$17.2M in fruit and vegetable benefits to 45,267 participants in Arkansas.
