### BREASTFEEDING IN WIC

Colorado WIC breastfeeding initiation rates increased by **6 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Colorado in 2022, **28 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$24.9M** in fruit and vegetable benefits to **66,674** participants in Colorado.

### CHILDHOOD OBESITY IN WIC IN COLORADO

The obesity rate among WIC toddlers in Colorado decreased **10 percent** between 2010 and 2020.
