BREASTFEEDING IN WIC

Delaware WIC breastfeeding initiation rates increased by **58 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Delaware in 2022, **24 percent** continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$5.6M** in fruit and vegetable benefits to **15,291** participants in Delaware.

CHILDHOOD OBESITY IN WIC IN DELAWARE

The obesity rate among WIC toddlers in Delaware increased **1 percent** between 2010 and 2020.
