BREASTFEEDING IN WIC

Florida WIC breastfeeding initiation rates increased by **15 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Florida in 2022, **17 percent** continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$122.2M** in fruit and vegetable benefits to **324,301** participants in Florida.

CHILDHOOD OBESITY IN WIC IN FLORIDA

The obesity rate among WIC toddlers in Florida decreased **8 percent** between 2010 and 2020.
