BREASTFEEDING IN WIC

Illinois WIC breastfeeding initiation rates increased by **11 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Illinois in 2022, **16 percent** continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$45.7M** in fruit and vegetable benefits to **121,344** participants in Illinois.

CHILDHOOD OBESITY IN WIC IN ILLINOIS

There was no significant change in the obesity rate among WIC toddlers in Illinois between 2010 and 2020.
