BREASTFEEDING IN WIC

The Inter-Tribal Council of Oklahoma WIC breastfeeding initiation rates increased by **130 percent** between 2000 and 2022.



Among WIC infants who initiated breastfeeding in the Inter-Tribal Council of Oklahoma in 2022, **23 percent** continued breastfeeding at 6 months.

CHILDHOOD OBESITY IN WIC IN THE INTER-TRIBAL COUNCIL OF OKLAHOMA

Childhood obesity rate, WIC toddlers, 2020..... **9%**



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$155,376** in fruit and vegetable benefits to **430** participants in the Inter-Tribal Council of Oklahoma.
