### BREASTFEEDING IN WIC

Mississippi WIC breastfeeding initiation rates increased by **23 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Mississippi in 2022, **12 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$17.3M** in fruit and vegetable benefits to **46,228** participants in Mississippi.

### CHILDHOOD OBESITY IN WIC IN MISSISSIPPI

There was no significant change in the obesity rate among WIC toddlers in Mississippi between 2010 and 2020.

Childhood obesity rate, WIC toddlers, 2020..... **14%**

Maternal mortality per 100,000 births, 2017-2021... **38.0**

Infant mortality per 1,000 live births, 2021..... **9.4**
