### BREASTFEEDING IN WIC

Missouri WIC breastfeeding initiation rates increased by **21 percent** between 2010 and 2022.



Among WIC infants who initiated breastfeeding in Missouri in 2022, **21 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$25.2M** in fruit and vegetable benefits to **65,725** participants in Missouri.

### CHILDHOOD OBESITY IN WIC IN MISSOURI

The obesity rate among WIC toddlers in Missouri decreased **12 percent** between 2010 and 2020.

Maternal mortality per 100,000 births, 2017-2021... **25.2**

Infant mortality per 1,000 live births, 2021..... **5.8**
