#### **BREASTFEEDING IN WIC**

Montana WIC breastfeeding initiation rates increased by 5 percent between 2010 and 2022.

Among WIC infants who initiated breastfeeding in Montana in 2022, **32 percent** continued breastfeeding at 6 months.



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated \$4.0M in fruit and vegetable benefits to 10,958 participants in Montana.
