BREASTFEEDING IN WIC

The Otoe-Missouria Tribe WIC breastfeeding initiation rates increased by **11 percent** between 1998 and 2022.



Among WIC infants who initiated breastfeeding in the Otoe-Missouria Tribe in 2022, **7 percent** continued breastfeeding at 6 months.

CHILDHOOD OBESITY IN WIC IN THE OTOE-MISSOURIA TRIBE

Childhood obesity rate, WIC toddlers, 2020..... **22%**



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$65,268** in fruit and vegetable benefits to **176** participants in the Otoe-Missouria Tribe.
