BREASTFEEDING IN WIC

In 2022, **31 percent** of 6- to 13-month-old infants and children in the Standing Rock Sioux Tribe initiated breastfeeding.



Among WIC infants who initiated breastfeeding in the Standing Rock Sioux Tribe in 2022, **7 percent** continued breastfeeding at 6 months.

CHILDHOOD OBESITY IN WIC IN THE STANDING ROCK SIOUX TRIBE

Childhood obesity rate, WIC toddlers, 2020..... **19%**



Fruit and Vegetable Benefit: Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$64,500** in fruit and vegetable benefits to **183** participants in the Standing Rock Sioux Tribe.
