### BREASTFEEDING IN WIC

Tennessee WIC breastfeeding initiation rates increased by **183 percent** between 1998 and 2022.



Among WIC infants who initiated breastfeeding in Tennessee in 2022, **20 percent** continued breastfeeding at 6 months.



**Fruit and Vegetable Benefit:** Congress enhanced WIC's fruit and vegetable benefit to align with scientific recommendations. Current monthly benefit amounts are \$26 for children, \$47 for pregnant and postpartum participants, and \$52 for breastfeeding participants. In FY 2023, WIC provided an estimated **\$36.5M** in fruit and vegetable benefits to **95,262** participants in Tennessee.

### CHILDHOOD OBESITY IN WIC IN TENNESSEE

The obesity rate among WIC toddlers in Tennessee decreased **9 percent** between 2010 and 2020.
